

OUR JOURNEY TO A GREENER FUTURE



We're committed to transitioning our distribution site in Nottinghamshire to be net-zero carbon by 2024, as well as achieving net-zero carbon by 2050 across our whole business. We're leading with several initiatives to reduce our environmental impact and increase the sustainability of our operations and the products we sell in line with our purpose of making the world a better home.

Hydrotreated vegetable oil lorries

We're transitioning our HGV fleet to run on hydrotreated vegetable oil (HVO) by the end of 2023. HVO is a biofuel that originates from vegetable oils and reduces CO² emissions by 90% compared to diesel. HVO also produces much cleaner emissions with fewer nitrous oxides, meaning improved air quality for our colleagues, customers and local community.

Moving to more eco-friendly packaging solutions

We're collaborating with our bag, film and tub manufacturers to reduce packaging wherever possible, switch to more recyclable solutions like paper and cardboard, and use at least 30% recycled plastic across primary, secondary and transport packaging. We're also improving the recycling and safe disposal information on our plastic packaging labels to make sure plastics that can be recycled are, and in a safe way. Clearer recycling information on pack informs users of how to dispose of product residues and recycle packaging safely, and our new eco stamp highlights where packaging has been made from recycled content.

Biomass heating system

2022 saw the installation of our biomass heating system which runs off wooden pellets to heat our warehouse, offices and hot water.

The renewable heating system is expected to reduce carbon emissions by 150 tonnes per year through decommission and removal of our previous diesel heating system and gas boilers.

Reduced plastic on site

As well as various recycling initiatives on site, we've replaced the plastic air packs in our Gyproc Express boxes with shredded cardboard produced from recycled cardboard on site. We've also rolled out sustainable PPE for our colleagues which is made from recycled plastic and are exploring ways to reduce plastic in our POS and merchandise.


Sustainability Action Group

Our sustainability initiatives are driven directly by our colleagues through our Sustainability Action Group. Including colleagues across all areas of our business, the group manages our annual sustainability budget, gathering ideas and suggestions from their peers and putting these into action.

So far the group have introduced Sustainability Action Days where colleagues can take a day of paid leave to volunteer on a sustainable project in their local community, they've organised the installation of animal nesting boxes in our biodiversity area, and have built strong partnerships with our local community.

1. Definitions

In these terms and conditions "Artex" shall mean Artex Limited whose registered office address is Saint-Gobain House, East Leake, Loughborough, Leicestershire, LE12 6JU and whose principal place of work is Pasture Lane, Ruddington, Nottingham, NG11 6AE, the "Goods" shall mean the products supplied or to be supplied by Artex under any Contract; "the Customer" shall mean the company, firm or person buying the Goods from Artex under any Contract and "Contract" shall mean a contract between Artex and the Customer for the sale and purchase of Goods. Any reference in these terms and conditions to any provision of a statute shall be considered as a reference to that provision as amended, re-enacted or extended at the relevant time.

2. Application of Conditions

All Goods supplied by Artex are supplied on the following terms and conditions and no variation of those terms shall have effect unless expressly accepted by a Director of Artex in writing. Artex's conditions exclude all other terms and conditions which the Customer may seek to impose whether or not the Customer's conditions are contained in any other acceptance or counter offer by the Customer.

3. Quotations

All quotations given by Artex are subject to acceptance by Artex on receipt of the Customer's order. Quotations are valid for a period of thirty days from date of issue and maybe withdrawn at anytime. A Contract will only be formed when Artex has accepted the Customer's order.

4. Price

All prices quoted are Artex's current prices at the time of delivery and are exclusive of VAT unless otherwise stated. The price payable for the Goods shall be the price ruling at the date of despatch and Artex shall be entitled to adjust the price of the Goods at any time between the date of the order and the date of delivery of the Goods to take account of any increase in costs incurred by Artex. A handling charge will

be made on orders that do not meet the agreed minimum order value.

5. Delivery

- 5.1 Delivery shall be deemed to have been effected:
- **5.1.1** Where the Goods are carried in a vehicle owned by Artex or in a vehicle owned by a carrier employed by Artex, when the vehicle is stationary as near to the point of delivery designated by the Customer as it can reasonably get and the delivery note is tendered to the Customer or the recipient of the Goods where delivery is not directly to the Customer.
- **5.1.2** In the case of export orders, upon delivery F.O.B. to Artex's nominated port of shipment.
- **5.1.3** In all other cases when the Goods leave Artex's premises.
- **5.2** Time for delivery is not of the essence and delivery times are estimates only.

- **5.3** Artex shall be entitled to make delivery by instalments and to invoice separately for each instalment. Where delivery is made by instalment each instalment shall be construed as the subject of a separate agreement to which all the provisions of these conditions shall (with any necessary alterations) apply.
- **5.4** Where Artex has agreed to deferred delivery such delivery shall be accepted by the Customer within six months from the date of the order. If the Customer fails to take delivery within such a period the risk shall pass to the Customer and the balance remaining undelivered together with storage costs shall be invoiced to the Customer and payment shall become immediately due.
- **5.5** Goods which the Customer agrees to collect exworks must be collected within seven days of Artex notifying the Customer that the Goods are ready. If the Goods are not collected within this period Artex shall be entitled to invoice the Customer for the Goods and to charge for storage of the Goods, the Goods being held at the Customer's risk.
- **5.6** Unless otherwise agreed in writing, all export orders will be delivered F.O.B. to an Artex nominated British port
- **5.7** Deviations in quantity of the Goods delivered from those stated on the Contract shall not give the Customer the right to repudiate the Contract, to reject the Goods (save in so far as they materially exceed the amount ordered) or to claim damages for breach of Contract and the Customer shall be obliged to accept and pay at the Contract rate for the quantity delivered (except in so far as the Customer has the right to reject the Goods under this condition).
- **5.8** The Customer shall ensure that the point of delivery designated by the Customer and all access routes to it are reasonably accessible to motor transport and shall also take such further steps as are reasonably necessary to facilitate delivery by Artex at such point of delivery.
- **5.9** Where Letter of Credit is the required payment method, delivery period shall commence only upon receipt of a Letter of Credit complying in all respects with Artex's requirements.
- **5.10** If an import licence, permit or other authorisation is required for the importation of the Goods into the country of destination, such licence, permit or authorisation must be obtained, or will be obtained, prior to shipment.

6. Payment

- **6.1** The price of the Goods (less any discount to which the Customer is entitled) shall be due and payable on the last day of the month following that in which the invoice is dated. The time of payment of the price shall be of the essence of the Contract.
- **6.2** If the Customer fails to make payment in respect of any invoice on the due date:
- **6.2.1** All invoices for Goods delivered for which payment has not been received shall become immediately due and payable not withstanding clause 6.1 or any previous agreement to the contrary.

- **6.2.2** Without prejudice to any other right or remedy available to Artex, Artex shall be entitled to:
- **6.2.2.1** Charge the Customer interest (both before and after judgement) on the amount unpaid in accordance with the terms of the Late Payment of Commercial Debt (interest) Act 1998 until actual payment on all overdue accounts; and / or
- **6.2.2.2** Cancel the Contract or suspend further deliveries to the Customer; and / or
- **6.2.2.3** Set-off any amounts Artex owes to the Customer by way of rebate payments, contract support payments or any other monies due from Artex to the Customer against any monies owed by the Customer to Artex.
- **6.3** Artex reserves the right at any time to demand a security payment before continuing with or delivering any order.
- **6.4** The Customer shall make all payments due under the Contract without any deduction whether by way of set-off, counterclaim, discount, abatement or otherwise unless the Customer has a valid court order requiring an amount equal to such deduction to be paid by Artex to the Customer.
- **6.5** Artex will make a search with a credit reference agency, which will keep a record of that search and the credit reference agency and/or Artex will share that information with other businesses. Artex will also make enquiries about the principle directors with a credit reference agency. Artex will monitor and record information relating to the Customer's trade performance and such records will be made available to credit reference agencies and other businesses in assessing applications for credit and fraud prevention. If the Customer does not want Artex carrying out such a search or sharing data, please do not complete an account application form. To the extent that the Customer supplies sensitive information then it will be kept in accordance with the Data Protection Act.

7. Risk and Property

- **7.1** Risk in the Goods shall pass to the Customer when the Goods are delivered to or collected by the Customer or its agent.
- **7.2** Notwithstanding delivery and the passing of risk in the Goods the Goods shall remain the property of Artex until the Customer has paid the full price for the Goods and all other sums owing to Artex under any Contract together with any interest payable under any Contract in respect of the Goods.
- **7.3** Until title in the Goods passes to the Customer the Customer holds the Goods as fiduciary agent and bailee for Artex and shall hold the Goods in good and substantial repair and condition properly stored in and protected and insured and the Goods shall be stored in such a way as to be clearly identifiable as belonging to Artex.
- **7.4** Until such time as the title in the Goods passes to the Customer (and provided the Goods are still in existence and have not been re-sold) Artex shall be entitled at any time to require the Customer to deliver up the Goods to Artex and if the Customer fails to do so forthwith to

enter upon any premises of the Customer or any third party where the Goods are stored and repossess the Goods.

7.5 Artex shall at any time be entitled to appropriate any payment made by the Customer in respect of any Goods in settlement of such invoices as Artex may in its absolute discretion think fit not withstanding any purported appropriation by the Customer.

8. Inspection

- **8.1** The Customer shall inspect the Goods on delivery or on collection as the case may be.
- **8.2** Artex shall be under no liability for any defects or shortages that would be apparent on careful inspection if the terms of this Clause are not complied with and in any event will be under no liability if a written complaint is not delivered to Artex within seven days of delivery detailing the alleged defect or shortage.
- **8.3** In all cases where the Customer complains of defects or shortages Artex shall, without prejudice to the question of liability generally, be under no liability in any event if it has not been given an opportunity to inspect the Goods before they had been used by the Customer.

9. Warranty

- **9.1** Artex warrants that it has title to and the right to sell the Goods.
- **9.2** No representation or warranty is given by Artex as to the suitability or fitness of the Goods for any or any particular purpose and the Customer shall satisfy himself in this respect and shall be totally responsible therefore.
- **9.3** The Service Charter should be read in conjunction with these Conditions of Sale. In the event of a conflict between the Service Charter and these Conditions of Sale then the terms of the Service Charter shall apply.

10. Items supplied by the Customer

The Customer shall be liable for all drawings, specifications and instructions issued to Artex with orders or pursuant to the Contract and shall indemnify and keep indemnified Artex against all loss directly or indirectly arising out of any error or omission from such drawings, specifications or instructions, and against all costs, claims, demands and expenses whatsoever, in respect of the infringement, or possible infringement, of any patent, copyright, registered design, design right or other third party right arising out of Artex's use of such drawings, specifications or instructions.

11. Liability Exclusions

- **11.1** Each of the sub-clauses in this clause are to be treated as separate and independent.
- **11.2** Nothing in these conditions shall exclude or restrict Artex's liability for death or personal injury caused by the negligence of Artex.
- **11.3** Artex is willing to undertake liability additional to that provided by this clause 11 in exchange for a higher price for the Goods.

- 11.4 Artex will either repair the Goods at its own expense or at its option replace the Goods if any defects which Artex is reasonably satisfied are caused by faulty design, manufacture, materials or workmanship provided that Artex shall not be liable for defects caused by abnormal use, misuse or neglect or use other than in accordance with any applicable Artex technical instructions or similar literature and provided further that the Customer informs Artex of the relevant defect in writing within seven working days of delivery (or where the defect was not apparent on reasonable inspection) within seven working days of discovering it.
- **11.5** Other than the terms set out in these conditions no other terms, conditions or warranties expressed or implied, statutory or otherwise, shall form part of the Contract.
- **11.6** Artex shall not be liable for any indirect loss or damage, loss of profit, loss of goodwill or loss of business opportunity suffered by the Customer or any indirect damage to property of the Customer or anyone else whatsoever howsoever arising and whether or not caused by Artex's negligence.
- 11.7 In the event that notwithstanding the foregoing provisions of this clause, Artex is found liable for any loss or damage suffered by the Customer then Artex's total liability for any one claim or for the total of all claims arising from any one act or default of Artex (whether arising from Artex's negligence or otherwise) shall not in any event exceed the Contract price for the Goods.

12. Insolvency of Customer

If the Customer being a company shall pass a resolution or suffer an order of a court to be made for its winding up or goes into liquidation (other wise than for the purpose of amalgamation or reconstruction) or makes any voluntary arrangement with its creditors or becomes subject to an administration order or an encumbrancer takes possession or a receiver or administrative receiver is appointed over any of the assets or property of the Customer or being an individual or partnership shall suspend payment or propose to enter into any composition with creditors or becomes bankrupt or in either case becomes unable to pay its debts (or have no reasonable prospect of doing so) or threatens to cease to carry on business then without prejudice to any other right or remedy available to Artex, Artex shall be entitled to treat the Contract as repudiated or suspend any further deliveries or recover the possession of any Goods for which payment in full has not been received without liability to the Customer and if Goods have been delivered but not paid for the price of those Goods shall become immediately due and payable notwithstanding any previous agreement or arrangement to the contrary.

13. Sample Goods

Under no circumstances will Artex sell its Goods by sample and their supply of sample Goods to Customers or prospective Customers is not intended to provide them with a contractual specification of the Goods or to constitute a sale or offer of sale by sample.

14. Health & Safety at Work

Artex gives notice to the Customer that information and product literature is available concerning the conditions necessary to ensure that the Goods supplied against the Contract will be safe and without risk to health when used, handled, processed, stored or transported by a person at work. The Customer should immediately contact Artex if he is not in possession of such information or literature.

15. Assignment

The Customer shall not assign or transfer or purport to assign or transfer any Contract to which these conditions apply or the benefit thereof to any other person whatsoever.

16. Force Majeure

Artex shall not be liable for any failure to deliver the Goods arising from circumstances outside Artex's control including for example acts of god, war, riot, explosion, abnormal weather, fire, flood, pandemic, strikes, lock outs, Government action or Regulation (UK or otherwise) delays by suppliers, accidents and shortages of materials, labour or manufacturing facilities.

17. Cancellation

No cancellation by the Customer is permitted unless expressly agreed by Artex in writing. In the event of a cancellation, the Customer shall pay the appropriate cancellation charge as set out in the Ordering and delivery guide under the section titled Order cancellation.

18. Notices

Any notice to be given hereunder shall be in writing and shall be deemed to have been duly given if sent or delivered to Artex at its address (given above) or such other address as that party may from time to time notify in writing and shall be deemed to have been served and sent by post 48 hours after posting.

19. Group Members

Artex is part of the Saint-Gobain group of companies and may perform any of its obligations or exercise any of its rights hereunder by itself or through any other member of its group, provided that any act or omission of any such member shall be deemed to be the act or omission of Artex.

20. Rights of Third Parties

Subject to clause 19, the parties do not intend that any term of the Contract will be enforceable by virtue of the Contracts (Rights of Third Parties) Act 1999 by any person who is not a party to it.

21. Waiver

No waiver by Artex of any breach of the Contract by the Customer shall be considered as a waiver of any subsequent breach of the same or any other provision.

Service Charter

Terms and Conditions

22. Jurisdiction

All Contracts between Artex and the Customer shall be governed and constructed in accordance with English law and all disputes arising in relation to such Contracts shall be submitted to the jurisdiction of the English courts save that Artex retains the right to take proceedings in any other court of competent jurisdiction.

23. Headings

Headings in these conditions are for ease of reference only and do not form part of the conditions and shall not be deemed to alter or affect the meaning of any of the conditions.

24. Bribery Act Compliance

The Customer shall ensure that in any dealings with Artex, neither it or its employees or agents shall commit any offence under the Bribery Act 2010 ("the Act") including not engaging in any activity, practice or conduct which would constitute on offence under sections 1, 2 or 6 of the Act. The Customer shall inform Artex immediately it becomes aware of any actions between the parties that could constitute an offence under the Act.

25. Sanctions Compliance

It is Artex and its group's policy to comply with all applicable sanctions and legal requirements for the import and export of goods, technology and services. Artex is committed to ensuring compliance with all regulatory and licensing requirements relating to international trade.

Artex does not permit the supply of any of its Goods to any individuals, companies or organisations that are subject to any trade, economic or financial sanctions, embargoes or similar restrictive measures administered, enacted or enforced by the UK, EU, UN or USA ("Sanctioned Entities"). By entering in to this Contract the Customer agrees not to re-sell or otherwise transfer the Goods, either directly or indirectly, to any Sanctioned Entities.

26. Export terms

26.1 In these Conditions "Incoterms' means the international rules for the interpretation of trade terms of the International Chamber of Commerce as in force at the date when the Contract is made. Unless the context otherwise requires, any term or expression which is defined in or given a particular meaning by the provisions of Incoterms shall have the same meaning in these Conditions, but if there is any conflict between the provisions of Incoterms and these Conditions, these Conditions shall prevail.

26.2 Where the Goods are supplied for export from the United Kingdom, the provisions of this Condition 26 shall (subject to any special terms agreed in writing between the Customer and Artex) apply notwithstanding any other provision of these Conditions.

26.3 The Customer shall be responsible for complying with any legislation or regulations governing the importation of the Goods into the country of destination and for the payment of any duties on them.

26.4 Where Artex agrees with the Customer that it will be responsible for delivering the Goods the Goods shall (unless agreed otherwise in writing between Artex and the Customer) be delivered FOB to the air or sea port of shipment and Artex shall be under no obligation to give notice under s.32(3) of the Sale of Goods Act 1979.

26.5 The Customer shall be responsible for arranging for testing and inspection of the Goods at Artex's premises before shipment. Artex shall have no liability for any claim in respect of any defect in the Goods which would be apparent on inspection and which is made after shipment, or in respect of any damage during transit.

26.6 The Customer shall be liable for and shall indemnify and hold Artex harmless from any and all liability, loss, claims, damages and costs, which Artex may sustain or incur, arising out of or in any way connected with the Customer's failure to comply with Conditions 26.3 or 25.

27. Data Protection

27.1 For the purposes of this clause 27, (a) "Data Protection Laws" means (i) to the extent that the UK GDPR applies, the law of the United Kingdom or of a part of the United Kingdom which relates to the protection of personal data; (ii) to the extent that EU GDPR applies, the law of the European Union or any member state of the European Union to which Artex is subject, which relates to the protection of personal data, in each case as updated, amended or replaced from time to time; (b) "EU GDPR" means the General Data Protection Regulation ((EU) 2016/679), as it has effect in EU law; (c) "UK GDPR" has the meaning given to it in section 3(10) (as supplemented by section 205(4)) of the Data Protection Act 2018; and (d) the terms "Data Subject", "Personal Data", "processing", "processor" and "controller" shall have the meanings set out in the UK GDPR.

27.2 Each party shall comply with the provisions and obligations imposed on it by the Data Protection Laws when processing Personal Data in connection with these terms and conditions. Such processing shall continue for so long as these terms and conditions are in force and shall be in respect of the following:

27.2.1 Categories of data: Contacts within each of the parties and the ultimate customer details;

27.2.2 Types of personal data: names, addresses, email addresses, telephone numbers and other contact details;


27.2.3 Purpose and nature of processing: (i) manage the Contracts between the parties including ordering, fulfilment and billing and (ii) fulfilment of such Contracts by delivering Goods to the ultimate customer on behalf

27.3 To the extent that a party processes any Personal Data on behalf of the other party, the processing party

(a) comply with the provisions and obligations imposed on a processor by the UK GDPR, including the stipulations set out in Article 28(3)(a) - (h) which form a part of, and are incorporated into, these terms and conditions as if they were set out in full, and the reference to "documented instructions" in Article 28(3) (a) shall include the provisions of these terms and conditions; and (b) not disclose any Personal Data to any Data Subject or to a third party other than at the written request of the other party or as expressly provided for in these terms and conditions.

27.4 The Customer agrees that Artex may engage third party providers including any advisers, contractors, or auditors to Process Personal Data ("Sub-Processors"). Artex shall ensure that its contract with each Sub-Processor shall impose obligations in relation to the Processing of Personal Data on the Sub-Processor that are materially equivalent to the obligations to which Artex is subject to under these terms and conditions in relation to the Processing of Personal Data.

27.5 If either party receives any complaint, notice or communication which relates to the processing of Personal Data by the other party or to either party's compliance with the Data Protection Laws, or if any Personal Data processed in connection with these terms and conditions is subject to a personal data breach (as defined in the UK GDPR), it shall immediately notify the other party and provide the other party with reasonable co-operation and assistance in relation to any such complaint, notice, communication or personal data breach.
